[PROPOSED] JUDGMENT

The Complaint and Cross Complaint of this matter proceed to Trial before the Honorable Stephen Pfahler with the Court taking the matter under submission and later issuing it's findings by Order dated October 27, 2015 finding as to liability:

For Plaintiffs Pravin and Nazrin Singh on the Complaint against All of Us Enterprises, LLC.

For Chandra Livingston on the Complaint against her by Pravin and Nazrin Singh.

For Pravin and Nazrin Singh on the Cross-Complaint against them.

As to Damages, the Court found:

Plaintiffs proved damages of \$40,000 but were 25% at fault reducing their economic

damages to \$30,000. Judgment for the Plaintiffs in the amount of \$30,000 against All of US Enterprises, LLC only. No Parties were entitled to or had proven any other item of damages claimed.


1 Further, on August 26, 2015 & September 8, 2014, this Court awarded costs and fees to


